MetInvestment is a unit-linked investment product that enables a client to invest towards a long-term goal while offering a flexible unit-linked savings benefit that will facilitate withdrawals at regular intervals.

Although encouraged, loan repayments are not compulsory and translate into low fund values at maturity.

To address poor client value for money and poor shareholder value, MetInvestment is modelled according to a two-pocket approach; consisting of a compulsory long-term Investment component, and a compulsory Withdrawal component for regular withdrawals. No withdrawals are permitted on the Investment component. Both savings pockets are unit-linked.
